Operations: Event management reserves the right to restrict vendors to acceptable behavior during any and all activities of Celtic Celebration, Inc. If for any reason a vendor's appearance or conduct is deemed objectionable by event management, the vendor will be subject to eviction from premises. This reservation includes persons, things, conduct, printed matter, or any act, or item of poor character which management considers objectionable to the event's well-being. In the event of eviction or restriction, Celtic Celebration, Inc. is not liable for returning entry fees except at their own discretion.

- All canopies and tents cannot encroach into the fire lane and **must be weighted down.**
- All canopies and tents must be **secured without stakes.**
- Pets accompanying vendors are not allowed in the vendor or event areas unless they are confined within a secured crate designed expressly for the purpose of pet confinement.
- Vendors are limited and subject to the discretion

Vendors agree that participation in any contest, games or activities may be limited. Vendor must be 18 years of age.

- By initialing the appropriate space below, the vendor acknowledges and understands that no insurance is available for coverage to the vendor unless otherwise provided by private insurance obtained by the vendor.

- Vendors are responsible for all applicable taxes, payable to vendor coordinator prior to their departure of the event Saturday.
- Returned check fee is \$25.00
- Checks will be returned to you if we are unable to place you in this year's event.
- **Early departure on Saturday will result in forfeiture of Cleaning Deposit unless approved by Vendor Coordinator**
- All entrants are required to leave the area in the same condition in which it was found. Cleaning deposits (\$100.00) will be returned in the same manner received after area inspection. Please write as separate check from booth fee.
- All Food and/or Beverage vendors must use a non-permeable ground covering to protect the ground and/or pavement in their spaces from grease and food products.
